opera singer, in which quality I am a competitor participating in the 2018 event series entitled Armel Operaverseny és Armel Opera Festival (Armel Opera Competition and Festival, hereinafter referred to as: the Opera Competition) organized by ARMEL Produkció & Sajtóiroda Közhasznú Nonprofit Kft. (hereinafter referred to as: Armel), hereby make the following declaration at the location and time indicated below (hereinafter referred to as: the Declaration), which Declaration is to be regarded as an irrevocable, express and unilateral commitment on my part, and includes my commitment regarding the conditions of competition as attached (hereinafter referred to as: the Conditions of Competition).

I declare to have read, understood, acknowledged and accepted all conditions included in the present Declaration and in the Conditions of Competition.

I declare that I am fully aware of the fact that Armel intends to record, reproduce, distribute, publish, broadcast and otherwise use my productions and shows performed in my quality as an opera singer during and in connection with the Opera Competition, including, but not exclusively, the casting, the rehearsals and shows (hereinafter referred to as: my Performance).

I declare that by completing, signing and submitting the application form I automatically accept the conditions laid down in the present Declaration and in the Conditions of Competition as mandatory contractual obligations.

In case that I reach the second round of the Opera Competition, I accept to fully comply with the Director's creative decisions and instructions throughout the entire duration of the Opera Competition.

If I am cast in a role in the target production, I accept the applicable daily rate and/or remuneration commonly used at the Theatre of the target production (where I am liable to appear for rehearsals), which remuneration is in line with the rates applied in the local professional practice.

I accept that I am required to appear at all rehearsals and shows scheduled by the Theatre of the target production indicated on the website of the Opera Competition, at the dates and times indicated by the Theatre, which I have already viewed and hereby declare to be suitable for me, and I undertake to stay at the disposal of the Director throughout this entire period.

Sound or audiovisual recording

I hereby give my irrevocable consent to having the sound or audiovisual recording of myself, created at any given time during the entire duration of the Opera Competition and Festival, published and used in any way seen fit. Furthermore, I declare that I have been notified of the recording in advance. I am fully aware of the fact that Armel intends to use both the sound and audiovisual recordings of myself during the use of my Performance and in the context of promoting and advertising the Opera Competition in the media. Also, I hereby give my consent to having the sound or audiovisual recording of myself published in an unchanged, edited or cut format, or in compilation with recordings of other performers.

By signing the present Declaration, I irrevocably transfer to Armel all my performer's rights, i.e. my so-called "related rights" that ensue from the performance of my Performance or in connection with the sound or audiovisual recordings of the work of opera or my Performance; furthermore, I irrevocably and fully transfer to Armel my performance as a performer, without any restrictions as to time, location, length, count or any other aspect. In particular, Armel will be entitled to using my Performance for the following purposes, exclusively and without restrictions:

- recording my previously unrecorded Performance;
- reproducing my Performance, in part or in full, onto any analog or digital media, for temporary or permanent purposes, in a direct or indirect manner, including the sound or audiovisual recordings of my Performance as well as the reproduction of my Performance in catalogs, in short brochures or any other promotional material, in print, in electronic form, in the press, in collections, in databases or in multimedia works;
- broadcasting my previously unrecorded Performance through any technical means, on any radio or television channel, including any analog or digital terrestrial, satellite or cable broadcasting or any other form of communication to the public, except if the Performance intended for broadcasting or publication is itself a broadcast performance;
- communicating my Performance to the public through cable or any other means allowing the audience to customize the time and location of access, including, but not limited to on-demand online broadcasting via any computer network, such as the internet, or any other telecommunications network, as well as rebroadcasting my broadcast Performance by way of repeated broadcasting, cable television broadcasting or IP TV; or
- distributing my Performance as well as all the audiovisual material recorded of my Performance or any recording of my Performance, by way of any analog or digital data carrier or media, including, but not limited to distributing my Performance by way of any analog or digital sound or video media, in catalogs, in short brochures or any other promotional material in any media, in print, in electronic form, in the press, in collections, in databases or in multimedia works.

Furthermore, by signing the present Declaration, I undertake to provide all legal statements with regard to my commitments and declarations related to the transfer of my rights under the present Declaration and to my related rights under copyright law, at the request and at the expense of Armel, if, in case of exercising such rights on the territory of any given foreign country, the national law of the given country indicates the provision of such legal statements as a prerequisite for enabling the enactment of the present Declaration.

I hereby provide Armel with my final and irrevocable consent for storing and handling my personal information, exclusively in accordance with the agreed conditions, to the extent justified by the purpose and duration of the competition.

By signing the present Declaration, I acknowledge that the laws of Hungary shall prevail with regard to the interpretation of the present Declaration and the transfer of my related rights under the present Declaration.

If any dispute arises between Armel and myself in connection with the present Declaration that cannot be settled amicably, I accept the exclusive jurisdiction of the Municipal Court of Budapest.
